2. Riverside Village (Kristi Blythe, BC Housing)

- Formerly Heritage River Inn
- Updates to building for safety
- Onsite manager and property manager not operated by a non-profit
- 32 units utilized; some individuals, couples and families moving in next week
- All units with kitchens utilized; some units do not have kitchens and will not be used at this time
- 4 units may be available to be filled
- Longer term plans for the property- may renovate to include kitchens or other creative use of units in other capacity
- There may be opportunity for former tenants who were not in hotel to be included in remaining units
- SRD evacuation maps can be provided for evacuation routes

3. City Update (Cleo, City of Campbell River)

- Portland Loo- coming next month!
- Health & wellness grant coming to community for \$35 000 for 'Get the Point' a peer community clean up project via the CR Community Action Team and KDC Mobile Outreach Unit for Housing and Social Supports (MOUHSS)
- Rose Bowl- Announcement from BC Housing regarding purchase of restaurant 20 beds for Bridge to Housing as response to homelenssess (a step up from emergency housing/shelter)
- To open by end of summer; this will be a bridge to supportive housing developed in the future months (40-50 units)
- Urban Indigenous Housing Group supporting a design charrette for supportive housing

Bridge to Housing- Operations Update - Taryn O'Flanagan (VIMHS)

- Custom built pods x20
- Recreation space for residents onsite
- Meals provided for breakfast and dinner
- Community process to be held by VIMHS for selecting residents for the 20 beds available
- 24/7 staffing with supports onsite for residents
- Housing is temporary with the intention to roll into supportive housing

- Letter to City Council received no response from Council regarding relaxation of camping bylaws
- Vulnerable populations working group to address next steps to address this

5. COVID-19 Outreach Team & Schedule (Christine Colbert, Division of Family Practice)

- Sees approx. 60 clients on the MOUHSS
- MOUHSS has temporary support from Div. of Family Practice for physicians onboard the MOUHSS
- Provides COVID-19 testing onsite
- MOUHSS not well received downtown by businesses in the area
- Shared anecdotes of success for vulnerable populations engaging with physicians who have not utilized traditional health services previously
