- 4. Coalition Operational Updates (Stefanie Hendrickson)
 - a. Aboriginal Coalition to End Homelessness Culturally Supportive Housing Toolkit (Dec 8)
 - i. As per the meeting invitation email, the Aboriginal Coalition to End Homelessness has created a Culturally Supportive Housing Toolkit. They will be coming to Campbell River on December 8th (Noon to 4pm).

 - i. This has online, at-your-own-pace learning opportunities for anyone working or volunteering in this sector
 - 1. Variety of front-line, management, systems-change, program development, etc resources on a wide range of topics.
 - 2. Can be a great tool for onboarding new employees or to broaden training for existing staff



- d. Finally, I wanted to take a moment to give a shout out to all of those people doing the work on the ground. This is hard work. There are those of us who are working on the systems change, policy, data, and advocacy level, and then there are those people who are working within these systems to do their absolute best to serve the folks experiencing homelessness.
 - i. For those of you who don't get the chance to see these front-line agencies and individuals in action, I think you would be amazed at the work that is going on
 - ii. Sometimes it is so easy to notice the negative things. All the challenges. All of the barriers. All of the systems that need to be changed. How overwhelming it all is. So, just for a moment, let's celebrate the wins. The agencies and people who bring exceptional programs and services to the community, who are doing their best to make a difference in what sometimes seems like almost impossible circumstances. Congratulations for all of the little things that you do every day. They are the big things.
- 5. Point in Time Count, 2023 James Casperson, HSA-BC 15 min
 - a. Information, update, and discuss date
 - b. What is it?
 - i. A 24 hour snap shot of what homelessness looks like in the community
 - ii. Campbell River's last one was in 2021 and 2018 before that shows trends over time
 - iii. Shelter count the night before and street count on the day of
 - iv. Collects demographic information that can then be used by communities and governments
 - v. Stefanie will be the local coordinator
 - c. Importance of Point in Time Count
 - i. Has exceptional ability for advocacy
 - ii. Stories come out of the data
 - iii. Data is used by local and provincial governments (ex. BC Housing) as well as many service agencies for the purpose of grant writing, advocacy, myth busting, etc...
 - iv. Data is a source of information for the province as to the level of need in our community
 - d. Date discussion
 - i. We want some consistency in order to keep the methodology but could look to adjust by a couple of weeks either way if needed
 - ii. Last year was very cold and wet and it was challenging to find folks
 - iii. For MHSU teams, Wednesdays tend to be better
 - iv. Avoid cheque day, April 19 as attendance drops at programs
- 6. Emergency Weather Shelter update and discussion Sue Moen 5 min
 - a. We've had a bit of a stall due to location
 - Good news is that BC Housing has approved funding for a temporary shelter. A
 temporary shelter is one that is open nightly for a specific period of time (Ex. Nov 15 to
 March 31). This is different than an Emergency Weather Shelter that only opens on



- specific nights. Temporary shelters allow for more consistency for folks and tend to see better usage because of that consistency
- c. We also have 12-13 interested people willing to work in the shelter and we have training available to them
- d. If anyone can help with location, please let us know we have looked into churches, commercial spaces, non-profit spaces, etc...
 - i. Shawn Kwesa Place may be able to make space available in the current storage room
 - ii. Mary Catherine a big thank you to Sue for continuing to do this work and work through the incredible barriers that stand in the way.

7. Good news stories, updates, and discussions - from the floor, as time permits!

- a. Lucas via chat peers have been helping with downtown events and it's been great
- b. Shawn shout-out to Tracy for helping a local senior to get housed. He is now housed and has been sober for almost 2 months
- Sara The Art Hive was recently featured in a video as well as in the Legislature thanks to MLA Babchuk
