## 3. Coalition Operational Updates (Stefanie)

- a. Strategic Planning update
  - i. What: The Coalition has hired Resilience Planning to undertake a strategic planning process / organizational review for the Coalition
  - ii. Why: To assess the current model of the Coalition. To create a plan with strategic priorities over the next 5 years. To gain understanding about the community's relationship with the Coalition

## b. System Inventory update

- What: The Coalition hired Jennifer Banks-Doll to create a System Inventory of affordable and "social" housing units and programs/services often accessed by people experiencing homelessness
- ii. Why: To create a livable community asset that can guide service and housing development. To begin background work to better set the community up for future funding streams (such as the Federal Reaching Home Designated Stream)
- iii. Caveats:
  - 1. Not exhaustive
  - 2. Living list as programs are changing continuously
    - a. Please let Stefanie know if there are updates to your agencies programs

#### iv. Results:

- 1. A list of 29 housing places consisting of over 700 units or beds
  - a. Wide variety: shelter, transitional, specialized, affordable, etc...
- A list of 59 programs and services commonly accessed by people experiencing homelessness or by populations that have a historically high risk of experiencing homelessness
- 3. Data on how these programs and housing coordinate with each other (coordination of waitlists, intakes, referrals, assessments, etc...)
- 4. Pending a report on "What We Learned" about how people navigate this system and the barriers and challenges to that navigation

#### v. Use of data

- 1. Available for community partner use
  - a. Ex. to assess gaps/needs in advance of a program development/changes
  - b. Ex. to gain data for funding, housing, program applications
