5. Quinsam Campground - Notice to Vacate Announcement

- a. Provincial Ministry of Forests, Lands and Natural Resource Operations intends to issue and post "no trespassing orders" on Crown Land located at 2600 Quinsam Road (AKA Quinsam Road Camp). The order will be posted and delivered by hand, within the coming weeks. Once the order has been given, residents will have seven days to vacant the land and remove their belongings. The occupants will be advised that they may temporarily camp at Nunns Creek, but most vacant by 0900 hrs the following morning as per current case law.

- Question people at encampment are not interested in leaving site; however enforcement from RCMP to follow in coming days/weeks
