 - 1. Kaitlyn is a registered social worker with Island Health. She lives in Campbell River but currently serves the Gold River/Tahsis/Tsa'Xana area. Kaitlyn would bring a health perspective to the CC. She is knowledgeable about harm reduction and substance use concerns and would be a valuable resource to help us better understand the challenges of homelessness and substance use as related to each other.
 - Kaitlyn has experience with strategy, development, planning, communications, fundraising, and front-line work. She will commit to a 2-year+ term.

5. Poverty Reduction Plan (Stefanie - Group discussion) - 10 min

- a. City of Campbell River and SRD staff are currently exploring the possibility of applying for a grant to support the creation of a poverty reduction plan for the region.
 - i. This type of plan is a prerequisite for provincial poverty reduction funding streams



- ii. The plan can include any or all of:
 - 1. housing, employment, education/training, income supports, social supports, family/youth/children
- iii. They are gauging support for this plan.
 - 1. If they were successful in this funding and in hiring a consultant to undertake the work, would your agency be supportive of the process by providing information, participating in engagement sessions/interviews, providing access to research/data, supporting engagement with people with lived experience in your area of expertise, etc...?
 - a. Coalition yes, if housing is a topic
 - b. Niefs yes, for employment/training
 - c. Salvation Army (Sue) will support

6. Quinsam Heights Neighbourhood Plan (Jason Locke) - 10 min

 - 1. Situation Table is bringing this free training to CR on March 1. It's a full-day training that includes a certificate. We are able to open it up to other agencies locally.

- v. Stefanie, on behalf of Sara Lopez Assu Campbell River Art Gallery
 - The CRAG received a letter from the City accusing them of "allowing" encampments and loitering on the property and bringing their lease into question.
 - a. Sara felt that the letter placed blame rather than found solutions. The letter came without prior dialogue/discussion with Sara
 - b. This is a developing situation and she will keep folks updated, but she would appreciate support, if offered and needed
 - c. As a note, the Coalition will offer our support with facilitating meetings, providing letters, as needed. As you all know, the Coalition is about just that...coming together to create the best possible outcomes. We are passionate about communication, collaboration, relationship-building, and multi-sector solution-focused action. We believe that it is in the healthy relationships that a difference can be made. We are happy to do our best to help facilitate that spirit.
