b. System Inventory

- i. Jennifer Banks-Doll has been hired as a consultant to undertake 'Tier 1' of a homelessness systems inventory.
- ii. This work will help: Better identify gaps in services/funding being accessed/ housing, position the community better for future funding opportunities (ex. Federal Reaching Home designated stream), lay the groundwork for a collaborative homelessness system ("any door is the right door"), support agencies who wish to apply for funding or develop additional programs
- iii. Jennifer will be reaching out to the ~10 organizations who provide 80%+ of the services for people experiencing homelessness (prevention, support, and housing)
- iv. The project will include peer engagement regarding experiences with system navigation
- v. Project will also include an in-person meeting with agencies and peers to discuss current homelessness system navigation and map-out what a journey from being unhoused to housed may look (this example journey will be made available to community members who are looking to better understand the complexities and challenges related to becoming housed

c. Strategic Planning

- Selection is currently underway to hire a consultant to create a 5-year Strategic Plan for the Coalition. Results will include recommendations as to how to the Coalition can better position itself to serve the community and become sustainable
- ii. This work will happen over the fall and winter with final product delivered in the spring.
- iii. It will include engagement with peers as well as key community partners (City, SRD, local non-profits, etc...)
- iv. We hope to answer questions such as: What are we doing well? How could we be more impactful? Is our current Coalition model working or could we be more



effectives/sustainable as a non-profit? Is current system-level work serving the community well or should we explore expanding our mandate and capacity?

- Safe spaces will be created with the consultant and without Coalition staff/volunteers present so that people can feel free to be candid in their feedback.

 - ii. Eligible organizations include: Non-profit, co-operative, and municipal housing providers. Including Indigenous in/out of community. Partnerships between for-profit and non-profit are allowed.
 - iii. Housing consists of 30% market rent, 50% Rent Geared to Income (RGI), %20 deeply affordable (i.e. income assistance rate)

 - Specifically for people experiencing homelessness
 - ii. Projects include 24/7 support services for tenants
 - iii. Building and land is owned by Province, building and support managed by non-profit

6. SRD Housing Accelerator Fund Application and Housing Service (Madison Stewart)

- a. Housing is a key priority area with the Strathcona Community Health Network
- b. SRD Housing Service has been identified for many years as a need for the region. A Housing Service has been approved
 - i. Housing services can:
 - 1. Requisition funding
 - 2. Apply for grants to partner with non-profits to build housing
 - a. Current priority is workforce housing but that may be expanded in the future now that the housing service is being developed
- c. SRD has also applied for the Housing Accelerator Fund
 - i. This is an incentive fund to make housing development rapid and reduce barriers
 - ii. SRD fit under the rural and remote stream
 - iii. SRD applied for:
 - 1. Housing Service Bylaw (passed in August)
 - 2. Climate Adaptability Plan
 - 3. Zoning Bylaw Review (Areas B,C,D increase density and promote secondary suites and affordable housing options)
 - Delegated authority bylaw planning staff can approve instead of going to board
 - 5. Building Service for Areas D and C
 - iv. Not sure when successful projects will be announced

7. City of Campbell River update (Serena Klaver)

- a. Long-Range Planning Department
 - Has been actively working with community partners to try to actualize a Village Project (such as in Duncan - low-barrier tiny home village for people experiencing homelessness)



- ii. Willis Rd project (treatment centre with second-stage housing) funding has been difficult to obtain but the City remains optimistic that this project will move forward once funding becomes available
- iii. Working on updating the Community Safety Plan
- iv. Working with SRD, Strathcona Community Health Network, and Coalition to lead a Poverty Reduction Plan via UBCM grant funding - RFP submission deadline for consultants is tomorrow
- v. New accessibility laws came into effect City is partnering with SRD on accessibility and inclusivity with SRD taking the lead

 - i. There is a new FNHA Urban & Away From Home Team
 - 1. Grant should be announced soon up to \$25,000 meant for service providers providing service to urban Indigenous populations, including: homelessness support, mental health support, and primary care
- e. Stefanie Coalition
 - i. NICHI will be holding federal funding for Indigenous housing projects in urban, rural, and northern areas. This is "by Indigenous, for Indigenous" funding and so will be available to Indigenous-led organizations.
 - 1. Funding will be available for housing in community or housing serving urban Indigenous. Application process expected to open soon
